Cleaning

Use damp cloth with normal detergents. Do not submerge the seat in the bath water; drain after use and dry the seat. Don't use harsh abrasives or bleach based cleaners.

- Please help people with movement difficulties to seat on the products.

- Add the lubricating oil to the transmission parts regularly.
